

ELIGIBILITY FOR APPLICANTS:

Applicants must fulfill the educational qualifications, experience and age limit and other criteria for the post, as on the last date of receipt of the applications; failing which the application shall be summarily rejected. No correspondence will be entertained in this regard. Candidates are, therefore, advised to satisfy themselves before applying for the post that they meet the prescribed essential qualifications and experience. The prescribed essential qualifications are the bare minimum, and mere possession of the same does not to entitle candidates to be called for the written/practical Test. The candidate who are

willing to apply for more than one post are required to submit a separate application against each post in the prescribed format.

AGE RELAXATION FOR GOVERNMENT SERVANTS:

The upper age limit is relaxable for Government servants upto 10 years. The age relaxation will be admissible to such of the Government servants who are working in posts which are in the same line or allied cadres and where a relationship could be established that the service already rendered in a particular post will be useful for the efficient discharge of the duties of the post(s) recruitment to which has been advertised. The above concession will be admissible only where an employee has rendered not less than three years continuous service under Government.

Age relaxation will be admissible to physically handicapped person and ex-servicemen as applicable in accordance with the orders issued by the central government.

SCHEME OF SELECTION

Selection of the aforesaid post will be on the basis of a written and practical test which will be conducted by a duly constituted Selection Committee. However, if the number of applications received for the post is large, then the appointing authority reserves the right to lay down any criteria for the purpose of the short listing of the candidates for selection tests.

- 1) Number of vacancies of the posts mentioned above may be increase or decrease as on date of result declaration of result.
- 2) Crucial date for determining the age limit shall be the closing date for receipt of applications from candidates in India (and not the closing date prescribed for those in Assam, Meghalaya, Arunachal Pradesh, Mizoram, Manipur, Nagaland, Tripura, Sikkim, Ladakh division of J&K State, Lahaul and Spiti district and Rangi Sub-Division of Chamba district of Himachal Pradesh, Andaman and Nicobar Island or Lakshadweep).
- 3) Only the date of birth as recorded in the Matriculation/Secondary Examination certificate or an equivalent examination will be accepted and no subsequent request for its change will be considered or granted.
- 4) Candidates claiming to OBC status may note that certificate on non-creamy layer status in the prescribed format (Annexure-II) should have been obtained within 3 Years before the closing date.
